Chapman Exchange

This must be one of the largest Chapman Exchanges we have ever published. Part of it is because since the last newsletter I've tried to reach about 150 new Chapmans on Prodigy to see if they were interested in sharing their Chapman information. Their response was more than unexpected.

Remember you are reading this section for two reasons- (1) to see if there is any way you can help any of these folks to learn more about their Chapman. If you have information or can suggest something they might do then let them hear from you (and please send me a copy). Notice that you can reach many of them on Prodigy if you are a subscriber to the service. Until there is a decline in the use of Prodigy I plan to include Chappies Prodigy ID along with their address. I recommend that when you exchange information with each other on Prodigy that you do it on the Genealogy Bulletin Board. The second reason you read the following- of course- is to see if you can find any information you need. In this regard do not fail to follow through and check the Chapman Lineages and Chapman Biographical Reference for further information from these folks. You will recognize them by the Chappie reference which is ### AAA (usually 3 numbers and 3 letters). The number is the subscriber number and is used only for paying subscribers (some may be expired).

I tell the folks I contact on Prodigy that I'll not publish an inquiry for them unless they send me a mailing address. I don't want to become a middle person on a lot of exchange between two of you (but I do want a copy). I'm making an exception to this rule in several instances and showing some folks without a mailing address. Those of you on Prodigy may be able to reach them via that service. I'd like copies of your Prodigy messages also. I normally copy those between two Chappies from the bulletin board, but if you write private messages you cut me out completely. I find it just about impossible to check Prodigy often enough to make sure I don't miss a Chapman message so hard copies from you will be appreciated.

I want to emphasize how much I need your help in keeping up with all these Chapmans. I'm so deep into the Chapman forest that I can't see the Chapman trees anymore. Tell me if there is some probable connection I've failed to mention. If you don't like something I've written- or failed to write- then please let me hear from you. All this is done for your benefit.

31.516 KATHRYN AINSWORTH 000 AIN ID#CWSN40A

Kathy sent, "My Chapman is **REBECCA CHAPMAN** born 2 Dec 1786 in CT to **JABEZ CHAPMAN**. Rebecca married Alden **KEITH** (date is still unknown) but I have very recently narrowed down the place and now hope to find the date. (Warsaw, Wyoming County, NY.)" We sent her some data from Rev. **F. W. Chapman's** 1854 book and received this response- "The packet arrived in yesterday's mail. You'll never know how my day was made by the information contained in that envelope!" The worksheet she

submitted showed **REBECCA CHAPMAN** as her husband's 3rd great grandmother. She was born about December 2, 1786, died April 10, 1859, and is buried in Assyria, Berry County, Michigan. See Chapman Lineages for the rest of the line back to **ROBERT CHAPMAN** b. ca 1616 England.

"Does anyone have ancestors / parents / siblings of **WILLIAM W. CHAPMAN** b. 1790/93. M. Eliz **HESTER** 1813 M2 Rebecca **RHODES LUCAS** ca 1858 Dale Co AL. W. W. C. died ca. 1865." Carol sent the following in a Prodigy message. I was hoping for additional information from her to supplement this but have not received it. "I am researching the following Chapman line: **JANE (JENNIE) CHAPMAN** b. 1814 SC m. 6 Oct 1828 Hall Co GA to John (Jaskey) **PATTERSON** (b. 1794 SC) res. Board Town, Gilmer Co GA. Siblings (?) **HENSE CHAPMAN** b. 1806, **VIOLET CHAPMAN** (b. 1810) **JOHN CHAPMAN** (b. 1813) **RUCHELLE CHAPMAN** (b. 1820) **FIELDS CHAPMAN** (b. 1821). Family tradition is that Jane's mother (Christiana?) was married to a SC plantation owner . . his plantation being near the Clemson area and/or John C. Calhoun's. Jane's father was cruel to her mother, and one night her mother fled to Georgia with the children. Jane was an infant at the time. Does anyone out there working on SC Chapmans have a family where the mom & kids disappeared?" Believe it or not but they also have Alford/Halford ancestors. We are anxious to learn more about them.

August 21 Wayne came on Prodigy with "I need the ancestors of **OBADIAH CHAPMAN** who moved to Sharon CT from Colchester CT in 1741. He may be connected to Saybrook Chapmans, but I can't find the connection. Can anyone help?" The next day he had a response from **John Henderson** 162 JOH ID#SMPW55A connecting him to the **WILLIAM CHAPMAN** b. 1633ca England branch. Wayne later provided

us additional information on the descendants of **OBADIAH CHAPMAN**. See Chapman Lineages for the rest of his Chapman ancestors.

Mimi Jo had an inquiry on Prodigy and I almost had replied before it dawned on me that I was talking to a long time Chappie. Her inquiry read- "Seek proof of parents of **JACOB CHAPMAN** b. VA 1780 moved to SC Spartanburg Co. by 1808 or before. Believed to be the son of **JOSEPH CHAPMAN**. Jacob m. Matilda **BISHOP**, d/o Edmond, and they moved to Cherokee Co. GA by 1845. Sons were: **ENOCH CHAPMAN**, **EDMOND CHAPMAN**, **DUDLEY CHAPMAN**, **JOSEPH CHAPMAN**. Daus. were: **TEMPERANCE CHAPMAN**, **MARY CHAPMAN**, **CAROLINE CHAPMAN** and **WINNIE CHAPMAN**." In a later message she wrote- "Gil. . . James Chapman (086 JW2) Comanche, TX and I have been exploring the possibility of my **JACOB CHAPMAN** being the son of a different **JOSEPH CHAPMAN**. It is one of those things that we may never really know. . ."

31.521 SUSAN P. CANNEY

Susan is the 6th great granddaughter of **SAMUEL CHAPMAN** born 1692 whose son **SAMUEL CHAPMAN**, born 1726 in New London, CT, married Mary **WATERMAN**. This comes from her worksheet on which she ran out of room. My first thought was that she probably knew the rest of her *American* Chapman lineage, but an accompanying pedigree form also stopped with Samuel born 1692. According to Rev. F. W. Chapman in his 1854 book on the Chapman family- Samuel was the son of **JOHN CHAPMAN** and his wife Sarah and John was the son of the immigrant- **WILLIAM CHAPMAN** who we suppose was born in England about 1633. This lineage has been published so the data is not being entered in the Chapman Biographical Reference. Readers can find Susan's direct

Chapman ancestors in Chapman Lineages.

Doug is looking for information on **MARY ELIZABETH CHAPMAN** born about 1841 in Indiana. Here's what he says he knows about her- "**MARY ELIZABETH CHAPMAN** b. about 1841 in IN. d. ?, Father b. in OH. Mother b. in IN (Parents info from 1880 Pike Co. IN census). Mary was the 2nd wife of Daniel Jackson RISLEY Sr. b. about 1835 in Pike Co, IN, d. before 1880 in IN. Mary had 3 known children: Daniel Jackson Risley, Jr., Mary Elizabeth Risley, and Manoah Jethero Risley."

31.523 ALBERT L. CHAPMAN

In addition to the questions here there will also be extensive data from Al in Chapman Feedback in a future issue (ran out of space in this issue). This came by Prodigy on 8/30. "I'm trying to sort out some info I got on a trip back east.. At the National Genealogical Soc. in Arlington I found Court Order books on Caroline Co. VA -- The first of any records I've found since it was supposed to have been burned. In any case I need help in linking **SAMUEL CHAPMAN** from Amelia Co. VA to the **SAMUEL CHAPMAN** in Caroline Co. One of the notations is as follows: p366-Sep. 10, 1736 '**MOSES CHAPMAN** acknowledges his deeds of lease and release of land to **SAMUEL CHAPMAN**' Does this imply a father/son relationship? As second question.. what is meant by ..."**GEORGE CHAPMAN**, garnishee, ... ? I've a number of references to several Chapman's including Samuel. I believe this is the one who moved from Caroline Co to Amelia Co VA but still need more confirmation... Thanks to you and others for any help." *He is expecting help. Don't disappoint him.*

31.524 DAVID CHAPMAN

I've asked David for a mailing address and the additional information on his Chapmans but

received no response. "My great-great grandfather was **ARCHIE LEROY CHAPMAN** b. 12 Nov 1876 in Rochester, MN m. Ruth PRETTYMAN. I know little more than this and would like to learn more." *If you have access to the 1880 soundex of Minnesota why don't you see what you can find for David. While you are at it why not extract all the Chapmans from that microfilm and send it on to us for publication- giving you full credit for extraction of course.*

31.525 DONALD CHAPMAN

On August 18 Don sent a Prodigy message asking for information on **JOHN CHAPMAN** from Ashford CT who married to Phenelippe BUGBEE April 15 1736. He belongs to the branch of **WILLIAM CHAPMAN** born about 1651-56 in England. The genealogy was published in CC #21 August 1988 page 16ff.

31.526 DONALD L. CHAPMAN

Donald is the 3rd great grandson of **JOHN CHAPMAN** who was born about 1755-60 in South Carolina, married Nancy WEST and had children: **NANCY CHAPMAN, JESSE CHAPMAN, WILLIAM CHAPMAN, JOHN B. CHAPMAN, WILEY CHAPMAN, & ZILLAH CHAPMAN**. Some of you will recognize this South Carolina family immediately. You will find more on this family in this issue in Chapman Lineages and the Chapman Biographical Reference. We are working on a special piece on this branch of the family that must be coordinated with several descendants.

31.527 DOUGLAS W. CHAPMAN
000 DUC

Douglas is one of the few Chapmans who can actually trace his line back to a published lineage of **JOHN (JOHNNY APPLESEED) CHAPMAN'S** branch of the family.

Unfortunately I don't have much respect for that particular published genealogy but in the end I may be proven wrong and the compiler proved right. Douglas does not claim to be close kin of Johnny Appleseed- just a descendant from the same immigrant. Their ultimate Chapman ancestor would be a **ANDREW CHAPMAN, SR.** of New Jersey. We don't know the name of his first wife, Douglas' 3rd great grandmother, but she died about 1827 and his second wife was Mrs. Almira (ROSE) BELL who he married about 1835. The families of this branch resided in north central Ohio and Allen County, Indiana. We have included what we know of Douglas' Chapman lineage in this issue but did not make any entries in the Chapman Biographical Reference. We are holding off until we can compile a complete genealogy of all the Chapmans Ms. Roebuck mentioned in her compilation.

31.528 ELIZABETH ANNE CHAPMAN
000 EZC ID#PNBT21B

(See also 31.552 below) After an exchange on Prodigy Elizabeth sent a worksheet showing that her 3rd great grandfather was **HARDY CHAPMAN II** born 1833 in Isle of Wight Co VA and he died there in 1908. He married Merit Jackson DAVIS. Elizabeth ran out of form or she undoubtedly could have provided more information. Since her earliest listed Chapman was Hardy II we can assume his father was **HARDY CHAPMAN I**. My initial thought was that he was probably the son of **HARDY CHAPMAN** who married Sally JOHNSON February 3, 1793 in Isle of Wight Co. But that is not possible if all our data is correct. Hardy II was born in 1833 and the Hardy who married Sally Johnson was dead by 1812 when his widow remarried. He is probably a grandson. Anyway we know that Chapmans resided in Isle of Wight County at the beginning of the 18th century and probably well before with Chapmans having been in Virginia since early in the 17th century. We have records on a number of early Isle of Wight Chapmans but so far cannot connect them to Elizabeth's branch. Maybe she will be able to provide additional data from which we can make some connections. Maybe you can add to what we

have here. Elizabeth's direct Chapman ancestors or listed in Chapman Lineages and all the Chapman kin she reported or in the Chapman Biographical Reference- both elsewhere in this issue. We added to the latter some other Isle of Wight Chapman data from our records.

31.529 GORDON R. CHAPMAN
159 GRC

In addition to a couple of very informative letters Gordon also sent a 17 page genealogy of his branch of the family. I'm going to delay publishing the genealogy until I can see if it is possible to get a disk file from him so as to minimize my input. Gordon descends from **STEPHEN CHAPMAN** who married Sarah FERRIS June 18 1776 in Westchester Co. NY. Stephen was a private in the Fourth Regiment, Westchester County Militia. Gordon believes that Stephen was a brother of **BENJAMIN CHAPMAN** a Captain in the Revolution. He was born in Litchfield Co. CT about 1750 and married Abigail _____. The following were extracted from one of Gordon's letters. Maybe you can help. "The DAR application . . . stated that Benjamin was born in Litchfield Co. CT but not the source of this information. Although I have searched the Barbour files in the Connecticut library and other sources at the Connecticut Historical Society, I have not yet found any reference to Stephen's line. This is where I need help. Published and unpublished genealogies for Connecticut Chapmans available at the Connecticut Library and the Library of Congress have not listed either a Stephen or a Benjamin descendent that looked likely."

"Researchers of Saratoga Co Chapmans should know of the excellent source, Henry Ritchie's unpublished notebooks, available on microfiche at the historical society in Ballston Spa."

"It is a mystery to me why Stephen and Benjamin went to Saratoga Co when, Benjamin, at least, was well established in Salem and in Ridgefield, CT. I thought it would be due to a bounty land grant but apparently neither applied for one (based on extant National Archive records) even though they would have been

eligible and Benjamin, as a Captain, could have done very well (the application by Stephen of CT, also listed in the Patriot's list, is not the same one). (Benjamin was included in a New York State listing of bounty land applications, in New York in the Revolution as Colony and State.) It also seems odd that there are no pension applications for Stephen or Benjamin in National Archives."

If you would prefer send the request and \$2 and I'll take care of the envelope and stamps. Be sure you refer to this inquiry so I can identify the package requested.

Data has been entered in Chapman Lineages and appears in this issue but the data for the Chapman Biographical Reference will be entered when the genealogy is published.

31.530 JAMES E. CHAPMAN
156 JAS ID#WWPB41A

James has an interesting Chapman ancestry- and it is one that was not all that unusual even in "early times." **ISAAC FRANKLIN CHAPMAN** is James' great grandfather. He was born out of wedlock to **NILA (LILA) CHAPMAN** who later married (1) Walter Rose and (2) John Walls. Isaac, who was born December 26, 1851 chose to keep his mother's maiden name. We are not sure where Isaac was born and don't have location data for most of his children. One was born in Lawrence County, OH so that would be our starting place. Readers who have access to the Ohio census of 1860 Ohio or the soundex records for 1880 and/or 1900 can help by checking these out and writing us about what you find on Isaac. See Chapman Lineages and Chapman Biographical Reference for more.

31.531 JAMES L. CHAPMAN
000 JAM ID#SRNN74A

James is the 2nd great grandson of **ROSWELL C. CHAPMAN** who was born about July 11,

1828 in Franklin County, IN. He died September 13, 1908 and is buried in Crown Point Cemetery, Howard County, Indiana. He served with the Union in the Civil War. He married (1) Tamseu M. JONES and after her death he married her sister (2) Ann JONES. Family tradition says they family came from the Chapmans who had a plantation in Port Tobacco, MD. More data is in the Chapman Biographical Reference and Chapman Lineages. We have put together a five page "Chapman Paper" on Roswell but will not include it in the newsletter because the probably small interest does not justify the reasonably large space requirement. Those interested my obtain a copy by requesting and sending along a large (#10 business size) stamped, self-addressed envelope. Be sure you reference this inquiry in your request for a copy.

31.532 JOSEPH CHAPMAN

I don't know if you want to try to help this guy or not. He's left two messages on the board and when I respond to try to get a little more information which I need to help him I get no response. The "F" in his ID suggests he may be a young person (child). His situation makes you want to help him and he does have an interesting situation.

"I was wondering if there is someone that can help me with my last name. I was never told much about my dad's side of the family. All I know is that my grandfather was born on the same day as I was, 8-29- . His age was unknown to me. I saw one picture of him wearing a military uniform. His name was **JOSEPH CHAPMAN**. My grandma had left him or something happen to him, I am really not sure. A couple years ago I went to a uncle's wake, on my dad's side family. And he had found out he had two half brothers he never knew. So if anyone can help please reply." And then a couple weeks later-

"Is there anyone in or from Mississippi that could help me find out about that side of my family. I am from La but my father side lives in Mississippi, and I know nothing about them. My grandfathers name was **JOSEPH CHAPMAN** and he was listed in the military and moved from state to state. Something happen between my grandparents and they were separated or divorced.

I have two half uncles that my father and I never had met before. But we had met one at a death of my uncle a few years ago. And I never seen him again. If anyone can help me on this please write me."

31.533 KENTON W. CHAPMAN

We have had several exchanges with Kent, well actually with Karina- his wife. Kent traces his ancestry back to **JOHN THOMAS CHAPMAN** born 1836 probably in England. He died March 13 1892 in Wisbech, Cambridgeshire, England as did his wife Sarah **WILSON**. We have information on two of John T's siblings but know nothing of his parents. We have been expecting some *interesting* information from them from Kent's grandfather but have not received it. He is trying to get it from a cousin in England.

31.534 LOWELL F. CHAPMAN
164 LFC ID#VWHH79A

We don't have Lowell's worksheet with all the details yet. I can give you enough information here to help identify him. As he continues to search for data to include in the worksheet maybe you can assist him. His great grandfather was **ALBERT ROSS CHAPMAN** born 1851 in "Flint Ridge" Muskingham County, Ohio. He married Nancy **HAMILTON** from Marion County, Ohio. See Chapman Lineages for more information and stay tuned for an update when Lowell sends the worksheet.

31.535 MARKHAM G. CHAPMAN

I was hoping to have data from Mark's worksheet which I sent to him in August. Here is the content of his message- "I'm hoping you could give me a little insight into the world of genealogy. I didn't realize that there was this much interest in the subject. [*He is talking about the number of CHAPPIES on Prodigy looking for their kin.*] I am very glad however. I would appreciate it if you

could tell me how to go about looking up my grandfathers family. I don't know much information. His name was **MARKHAM GARFIELD CHAPMAN**. My father tells me he was from either North or South Carolina. He also tells me that my great grandfathers name was the same. My grandfather married Estelle **GORHAM** of Florence, NJ. He would have been 70-80 years old now. He died about 19 years ago. I understand you have a database with info on Chapman families. Could you send me the Chapman family worksheet? I would very much like to add to your base."

I figure his grandfather was born about 1917 and died about 1973. With luck we may eventually find him in some 1920 census but do we start with the Carolinas? Note that the grandmother came from New Jersey. In the Social Security decedent file I find a Markham Chapman, SSN 148-09-5716, who was supposedly born Nov 22 1917 in NJ and died July 1975. If Mark will request a copy of the social security application it should give the names of this Markham's parents.

31.536 RICHARD HARMON CHAPMAN

Richard really needs some help and I'm not sure where we will find it. His grandfather was **MARLIN HARMON CHAPMAN** who I estimate was born about 1906- probably in Alabama. His parents were born in 1936/7 in Cullman County, Alabama. There is not enough to even do a lineage for him at this time. A search of the 1900, 1910 and/or 1920 Alabama Chapman census soundex microfilm would probably list Marlin and his parents family. If any of you have access to this microfilm and will check on the family please let us know. While you are at it why don't you extract all the Chapmans from the microfilms you check. Send it in and we will publish it- giving you credit for the extraction of course.

31.537 ROBERT A. CHAPMAN

This is more of an introduction than an inquiry.

Robert needs little help but some of you may be interested in him and his branch of the family. He is one of the few that I've ever heard from who were listed in one of the published Chapman works. Robert was listed in JOHN CHAPMAN of Spotsylvania County, Virginia THOMAS POWE of Cheraw, South Carolina and Related Families, Elsie Chapman Edmonds, 1971, Jackson, MS. As you will see in Chapman Lineages- Robert is a descendant of **JOHN CHAPMAN** who died December 1775 in Spotsylvania Co. VA.

31.538 WILLARD L. (W.L.) CHAPMAN
150 WLC

W. L. is the grandson of **ULYSSES HORATIO CHAPMAN** who was born December 15 1870 in Georgia, probably Union County. He died October 24 1944 in Red River County, TX. He married Virginia Lee **TERRY** in 1892. Someone who has access to the 1880 Georgia Chapman soundex microfilm could do a Chappie a great service here. While you are at it do a great service to lots of Chappies by extracting all the Chapmans from the microfilm- send them here and I'll publish them giving you full credit for all the extraction work. See Chapman Lineages and Chapman Biographical Reference for additional information.

31.539 WILLIAM CROSS
168 WMC

The following is his inquiry: "... is looking for information about the father and forebears of **WALTER ANDERSON CHAPMAN**, born c. 1809 in Greene County, VA and married to Louise Grey **SAUNDERS** c. 1836. The family moved from Greene County (formerly Orange Co.), or possibly Culpepper Co. to Missouri, settling in Crawford Co. His father *may* have been a slave owner named **JOHN CHAPMAN**, but I have no records earlier than the early 1800s. Family legend says **WALTER ANDERSON CHAPMAN'S** forebears came over from England to Massachusetts in the early 1600s (1617?), but this may not be accurate.

"WALTER ANDERSON

CHAPMAN's children include **WALTER FRANK CHAPMAN** (born c. 1833 in Greene Co.) **MARY FRANCES CHAPMAN** (born c. 1835 in VA; died c. 1860 in Texas), **MARGARET A. After Hulda died c 1851 in Coweta Co, GA. William m (2) **ELIZABETH CARR**, sold his property in Coweta Co. and moved to Austin Co, Tex. (Houston) c1852 where he was successful in the real estate business with his son, **WILLIAM THOMAS CHAPMAN**. Chapman street in Houston Heights is named for him. **WILLIAM THOMAS CHAPMAN** m Martha Ann **BOX MARSHALL**, widow of Burrell Jackson Marshall, after 1872 and the couple became founders of the Dripping Springs Academy (Hays Co.). **WILLIAM T. CHAPMAN** d March 6, 1917 and is bur in Wallace Cemetery on Wallace

Mountain. He had two children by Martha Ann, **WILLIE PEARL CHAPMAN** (1875-1949) and **MERCER EARNEST CHAPMAN** (1879-1945). Possibly **DONALD CHAPMAN** of Ca. or **Dan Franklin** of Tex might be able to shed some light on this branch.

From her first letter- "Our John GARNER married **JANE CHAPMAN** in Pickens S. C. circa 1800. I am almost positive that she is the daughter of **JOSEPH CHAPMAN**, who died in Pickens SC 21 March 1837. He didn't leave a will, but I have his estate papers. John Garner is mentioned as an heir, but Jane isn't mentioned. I know that the husbands took care of the business in those days, and I assume that John was acting in Jane's interest. Would you happen to know about this? I do know that **JOSEPH CHAPMAN** was in the Revolutionary war. I have a couple of papers about that, but nothing seems to mention Jane. The Garners left SC after **JOSEPH CHAPMAN** died. They first were in Hall Co. GA in 1840. By 1850, they were in Cherokee Co. GA. Some of the Chapman siblings were with them in both counties in Georgia." Part of a follow-up letter- "... Our **JOSEPH CHAPMAN** was born in Fairfax Co. VA 25 December 1745. He lived in Guilford Co. NC. Later, before 1790, he was in Pendleton District, SC. He married Jemima CASWELL, and they had 12 children, 6 sons & 6 daughters, all born in Pendleton, SC, most likely. He died 18 January 1836, intestate. Two members of the DAR received their membership through Joseph. He is said to have entered the Revolutionary War from NC, in the early years. He was wounded, and later after the fall of Charleston, he enlisted in the

SC troops. I assume he had removed to SC before the war was over. After Joseph died, without a will, his legatees petitioned the Pickens Dist. court to appoint Col. Benjamin Hagood, a friend of their father, as administrator of their father's estate. The court obliged. Col. Hagood paid all of Joseph's debts and collected what was owed the estate. He then divided the estate by twelve. He gave each heir \$1231.29, minus the amount the father had given each during his lifetime. The following heirs were: 1. the heirs of **JOSEPH CHAPMAN, JR.** (Joseph Jr. must be deceased), 2. Soloman McGee, 3. **ENOCH CHAPMAN**, William Lynch, **GEORGE CHAPMAN**, William Ladd, Nancy Patterson, **WILLIAM CHAPMAN**, **JOHN CHAPMAN**, **JEREMIAH CHAPMAN**, Elizabeth MaGee, John Garner. Soloman McGee, William Lynch, William Ladd, & John Garner were sons-in-law. Nancy Patterson & Elizabeth McGee were either widows or divorcees. Of course, the others were sons. I believe that they were listed according to birth order. I will be happy to copy these estate papers, if you would like to have them. I have sent for the military records of Joseph. I haven't received them. I don't have the names of all the daughters. I do know that Ladd married **POLLY CHAPMAN** and John Garner married **JANE CHAPMAN**. I hope to find the widows names in the 1830 or 1840 census. I just decided that I may get lucky in this effort. I definitely feel that these estate papers prove that Jane was Joseph's daughter. Their mother evidently was not living at this time. She was alive in 1820. I don't have a copy of the 1830 census for Chapman. I will check them at the library, tomorrow. . . ."

We would like to have the estate papers and any other documents available. This is another piece that fits into our 1790 SC Chapman puzzle.

Bob was a subscriber years ago but began concentrating on other surnames and dropped away from our Chapman effort. He has returned to Chapman now. In July he sent an inquiry that was too late to make the summer issue. In September he sent some changes and he sent some questions for me to try to answer. I'm publishing his inquiry as well as his questions. Maybe you will have better luck with the questions than I have. Bob's direct Chapman lineage is in Chapman Lineages in this issue but since he is from one of the established and published branches there is nothing in the Chapman Biographical Reference. Note that Bob has **JOSEPH CHAPMAN** as an ancestor. To fully understand who he is and how he fits one must study Chappie **Phil Ellsworth's** find article in CC #27, Fall 1991, pg 31.

"... needs information on **HENRY CHAPMAN** (and brother **TALBOT CHAPMAN**) of Vermont. He was born 29 June 1816, Vermont, and was married to Hannah Ann **LAMSON**, born 12 Aug 1822, Monmouth County, NJ. Henry's father was **ASA CHAPMAN** and was born in Vermont, and wife was Elizabeth **CHAPMAN**, born in Vermont. **ASA CHAPMAN's** parents were **ERASTUS CHAPMAN** and Polly **HUNTINGTON**, of Norwich, Vermont. **HENRY CHAPMAN** was 19 when he went to live in New Jersey. My question is: Was this **ASA CHAPMAN**, Henry's father? Any help would be most appreciated, and am willing to share any information."

Bob knows that Henry's fathers name was Asa Chapman based on a death certificate. His mother was Elizabeth Chapman (surname or married name unknown??). His problem is which ASA. "... I believe his father, Asa, is the one who shows up in Middlebury, Addison County, Vermont. My only hurdle I haven't been able to resolve is that records show that this Asa married a Levina or Lucina **BELL** in Middlebury, Addison County, Vermont, on 22 November 1814. The Elizabeth shown on Henry's death certificate may be possibly a second wife or Levina (Lucina) was called Elizabeth. Do you have any clues or

suggestions?" No, I did not.

Referring to published information on the descendants of **WILLIAM CHAPMAN** born ca 1633, Bob wrote- "I noticed a few mis-spellings and I am not sure what is right. For example, **SIMON CHAPMAN's** second wife, Alice. Was her last name spelled ROUSE or ROUCE? ... Is this information correct? If not, please let me know. I am a perfectionist and want to have things correct." Bob is in for some ulcers. Being an x-FBI man I can understand the "perfectionist" but it will never happen with names in genealogy. Consider the circumstances of education level and recording techniques to get some feel for the mishaps. Names were frequently written as the sounded. Many persons could not spell their own name- much less write it. Clerks, careless or careful, wrote what they thought they heard. We have found my surname, ALFORD, spelled over 100 different ways. I was forever finding my 2nd great grandfather in the 1850 census because he was listed under OLFORD. One early New England Alford changed his to ALVORD. Many use HALFORD or HOLFORD. Some use two "L's" to make sure it has the ALL sound instead of the AL sound. The Lord only knows how many ways one might spell ROUSE.

Then in the second letter Bob wrote- "... I now believe my **HENRY CHAPMAN's** father was the **ASA CHAPMAN** from Dorset, Bennington County, Vermont. I have enclosed a copy of his death certificate showing that he was born sometime in 1782, was 66 when he died on March 15, 1848. The death certificate for **HENRY CHAPMAN**, his son, shows his father and mother were born in Vermont. ... Do your records show an **ASA CHAPMAN**, born in about 1782 in Vermont?" No, I did not. As we continue to collect records we may stumble up on something if we can just relate it to this need when we find it. I *adjusted* Bob's lineage to compensate for this latest discovery of his. I assume there was no change in the parents of Asa. I did **not** make any adjustment on the parent of **JOSEPH CHAPMAN**.

The following was compiled from about six Prodigy messages received from Kay over a period of a week or so. "My maiden name is Chapman and I am trying to trace my family history. My grandfather was **ARCH CHAPMAN**, MD of Fort Smith, Ark. He died in either 1932 or 1933 in Ft. Smith. He was the son of a Mississippi Baptist Preacher." "My father is **ARCH CHAPMAN JR.** . . . Middle name for both Arches is **SYLVESTER**. Dad is 60 this year, his father committed suicide Dec 21 of 1932. Grampa was one of the founders of the Cooper Clinic in Fort Smith. I know my grandmother (who refuses to answer any questions about Grampa) was Grampa's second wife. I also know that Grampa was either the son or the grandson of a Baptist Minister from Mississippi. My grandmother is very sensitive about the subject of my Grampa perhaps because he was divorced. . . . I also know that Grampa was right around 43 when he died, and he had served in the military. He is buried in the military cemetery there in Fort Smith... about two rows away from the Hanging Judge... Grampa was in WW I, he was gassed in the war." Kay and I discussed whether we should pass this on to you for your help or not. She discussed it with her father and said to go ahead. A couple of us did give her some recommendations as to places to write for information to give her a lead. When we get some of the more recent Mississippi census we will have to look for Baptist preachers. I figure Arch Sr. was born about 1889 so we'll be waiting for the 1880 and 1900 census records.

Parts of two letters and a response- "My father, **LESLIE CHAPMAN**, came to Florida from Adair County, Kentucky in the early 1900's. His father, **WILLIAM S. CHAPMAN**, was married in Adair County, Kentucky to Alice E. THOMAS on December 22, 1887. I have been trying to locate his father, my great-grandfather, and have been following lots of leads that just disappear. On his (William S., my grandfather) marriage bond papers, he states that he was born in Lee County, Virginia, and I can find no family with the right names and dates. I have discovered him at 4 years old in the 1870 census for Taylor County, Virginia, with his mother, Elizabeth Chapman, living with a family named Odinalt. In the 1880 census for that county, I find that Elizabeth is now married to Newton Smith and that my grandfather (William S.) is still with her. But I cannot find his father (my great grandfather). Perhaps your newsletter will give me further clues to follow."

I gave her a couple of suggestions which included checking out **JOHN CHAPMAN** who was in Lee County, Virginia in 1850.

". . . You mentioned a **JOHN CHAPMAN** in the 1850 census of Lee County, Virginia. Last summer we traveled to Jonesville, VA, the county seat of Lee County and checked all their old vital records. They were very cordial there, and it was a lovely small southern town, but we found nothing. I had already located your John Chapman in the 1850 census, and their vital records told me that he had died July 5, 1866 and his daughter, Elizabeth had died July 7, 1866. John was married to Susanah and had a son, Clinton and another daughter, Mary. The dates and names don't match. I have checked census records for Lee County, VA for the years 1850, 1860 and 1870. I have checked the census records for Taylor County, Kentucky for the years 1860, 1870, and 1880 (1870 and 1880 were where I found my grandfather William S. and my great-grandmother, Elizabeth). In 1860 there was a **GEORGE CHAPMAN**, married to Elizabeth D. CHAPMAN, but the few vital records of that county I was able to obtain through the LDS microfilms skipped the important years. . . . When

I started this, I found a **WILLIAM S.**

CHAPMAN who was born in 1836 in Isle of Wight County, Virginia, and I did a lot of research on his family (I will send it to you for your records as soon as I can organize it), but I lost sight of him after the 1860 census of Isle of Wight County, where he was listed as still living with his parents, **HARDY CHAPMAN** and Matilda and he was a 'phiscian', probably a doctor. (See also 31.528 above.)

"The only information I have on my **CHAPMAN** is that my great-grandmother's mother was a **LAURA CHAPMAN** and in May 1849, which is when my great grandmother was born, they were in Medina City, Medina, Ohio. That is absolutely all of the information I have on the **CHAPMAN** I am related to." Medina County, Ohio was Chapman country. That can be good or it can be bad- depending on lots of things. Beth says the family was in Medina City when her great grandmother was born. It looks like there were 17 Chapman families in Medina County in 1840 and about 20 in 1850. In each of those years it looks like there was only one family in Medina City or township. In 1840 it was **ARDIN CHAPMAN** and in 1850 it was a **CHARLES CHAPMAN**. I'd bet a plugged nickel that **ARDIN CHAPMAN** was really **ARVIS CHAPMAN** who we know was living in Medina County in 1842. We obviously don't have all his children but we do *know* he had **EVERETT CHAPMAN** in 1828, **ARVIS SCOTT CHAPMAN** in 1839 and **ANNIE E. CHAPMAN** in 1842. There is plenty of room there for several other children. If it were me I'd take the "Medina City" clue and concentrate my search on Chapmans of that area. Probate and court records go back to about 1818 in this area and I think that is where I'd start my search. Of course that's easy to say since I'm not going to have to figure out how to do it. Descendants of this bunch moved to Illinois and many very close kin moved to Iowa.

With this additional data I was able to find where **LURENA CHAPMAN** married Sanford **BOQUE** March 16, 1881 in Piatt County.

Reuben was the son of **SAMUEL CHAPMAN** born 1791 and died 1861 who married Mary Lucinda NEWELL. Samuel was the son of **CAPTAIN REUBEN CHAPMAN** born 1746 and died 1824 who married Anne REYNOLDS. I was able to provide a little additional information and to put him in touch with a Chappie who contacted me several years ago. Don't you wish you were as productive?

7/21/92- Just for the record, my Chapmans are as follows: **JOSHUA P. CHAPMAN** born about 1850 married Francena THOMPSON born about 1850 birthplaces unknown. They farmed in southern Starke Co., Indiana around Ober and Ora down on the Tippecanoe. Their children were: **WARREN CHAPMAN** born September 2, 1872 who married Lenora Hovey. **MARTHA "JENNIE" CHAPMAN** born 1875 married Pete SPEELMON, **VIOLA CHAPMAN** born 1877 who married Joseph SCHUH, and **MYRTLE CHAPMAN** born 1880 who married Jacob WEISS. In this case Marc was providing me information on his Chapmans to distinguish them from some other Chapman data he had given me.

9/4/92- He reiterated the above and added "One grandchild was **PATTI CHAPMAN**, a radio singer/personality in Northern Indiana (South Bend?) in the 1920's."

9/9/92- He found his family in Cass County, Indiana 1880 census but with nothing new.

9/12/92- "Finally got my Chapmans out of Indiana! I am now looking for **JOSHUA P. CHAPMAN** b. Sep 1851 in Ohio. Parents also born in Ohio circa 1825. **MILTON HOMER CHAPMAN** b. Mar 1845 in Ohio, again both parents were listed as Ohio born.." (Milton's relationship - if any- is not yet known- see next paragraph.)

9/15/92 8:45 AM- "A trip to the Nat Archives today (after reviewing some of my old data) produced the following: My **JOSHUA P. CHAPMAN** is one of the sons of **WILLIAM P. CHAPMAN** born 3 October 1816 in Highland Co., Ohio. Married Nancy J. DUCKWALL born 24 September 1819. **WILLIAM P. CHAPMAN** was the son of **SILAS CHAPMAN**, a veteran of the war of 1812, born about 1797 in Virginia, and moved to Ohio prior to statehood. He was married to a ??? PEUSEY, also of Virginia. . . .

Additional children of **WILLIAM P. CHAPMAN** and Nancy DUCKWALL include: **JOHN CHAPMAN** b about 1840 in Ohio, **JANE CHAPMAN**, born about 1843 in Indiana, **MILTON HOMER CHAPMAN**, born March 1845 in Ohio, **JOSEPH FRANK CHAPMAN**, born 1847, and **CHARLES H. CHAPMAN**, born about 1856 and went to Kankakee, IL. (I have more info on most of these people)."

9/15/91 8:14 PM- "EUREKA UPDATE! (or, I spoke too soon. . .) According to the LDS Ancestral files, my **WILLIAM P. CHAPMAN** born 30 October 1816 in Highland Co., OH m. Nancy J. DUCKWALL born 24 September 1819 is actually the son of **ASABEL (ASAHEL) CHAPMAN** born 23 January 1794 in Union, SC; married Mary 'Polly' PUSEY born 28 February 1792 in Frederick, VA. **ASABEL CHAPMAN** is the son of **ISAAC CHAPMAN SR** and Anne ???. Children of **ASABEL CHAPMAN** include: **WILLIAM P. CHAPMAN**, **WESLEY CHAPMAN** born 1818 in Highland OH, **JOHN W. CHAPMAN** born 1819 married Margaret FORNSHELL, **JAMES MADISON CHAPMAN** born 29 December 1820 married

Hester Glass **GLOVER, GEORGE CHAPMAN** born 1824 married Margaret **ROBBINS, RACHEL CHAPMAN** born 1827, **JOEL CHAPMAN** born 1829 married Elizabeth **KENZER, JOSHUA CHAPMAN** born 1832 went to Starke Co., IN with Wm P., **CAREY CHAPMAN** born 1839 married Ruth A. **COMIS**. While Marc and others are exchanging information on Prodigy **Joan Chapman #110** is jumping in frequently with data from her family, her research, or census data she had been researching for us. I'm not including that here as it will be listed elsewhere at another time. Marc has sent data on computer disk which I included. I've included the above information in the Chapman Biographical Reference and have revised Marc's lineage in Chapman Lineages. In the former I've also included pertinent data found in the LDS-IGI. Marc sent an extensive sketch of **J. FRANK CHAPMAN** and the history of Starke Co. Indiana but that will be included in a later issue as space is quickly getting short in this one. If the "138 MBS" reference includes "+" it means I added something- probably from LDS-IGI.
